### CIRCULAR

#### **Subject: Vidyanjali Volunteer Drive**

National Education policy 2020 focuses on **Promoting Community and Voluntary Participation for Enhancing Quality of School Education**. Vidyanjali 2.0 Prog. is strengthening Govt and Govt-aided Schools of Delhi through Community and Private Sector Involvement. Most of the schools are onboarded and conducting Vidyanjali Activities through volunteers in an effective and appreciable manner.

PAB Minutes for 2022- 23 for the NCT of Delhi under Samagra Shiksha states regarding Vidyanjali 2.0 (6.10) that, "... the States and UTs are required to also identify the local volunteers/civil society organisations working in the field and encourage them to contribute to the schools through the portal so that the demand raised by schools could be met, leading to overall improvement in the quality of school education."

Also, NEP 2020 focuses on **Efficient Resourcing and Effective Governance through School Complexes /Clusters** which in turn is beneficial for the Schools. Keeping all these in view, the following strategies are suggested for successful implementation of Vidyanjali 2.0 Prog. –

- 1) **Volunteer Registration Drive**- Volunteer Registration Drive may be initiated at District level so that requirement of volunteer pool may be fulfilled. Alumni may be motivated for the same as well.
- 2) **Volunteer Pool**- Volunteer Pool may be constituted where a cluster of schools are there in order to use the resources of school appropriately and efficiently. A list of volunteers may be prepared service-wise and same volunteers may be registered and rotated in a cluster of schools.
- 3) **Rallies**- Rallies for the awareness of Volunteer Participation and Community Involvement may be initiated at District level. Schools, DURCCs, CRCCs, DNOs may collectively initiate the activity.
- 4) **Nukkad Natak**- Nukkad Natak may be conducted at DIET level in the community for the awareness of volunteer participation in the schools.
- 5) **Vidyanjali Mela**- For the registration of volunteers and awareness regarding Vidyanjali 2.0 Prog. among the community Vidyanjali Mela may be organised at District level.
