## CIRCULAR

Subject: Regarding launching of Central Sector Schemes of Pre-Matric and Post-Matric Scholarship schemes for Minority students for the year 2022-23 on National Scholarship Portal (NSP) by M/o Minority Affairs, Govt of India.

Attention of Head of all type of Schools are drawn to previous circular dated 04.08.2022 (again attached for ready reference along with all enclosures). The said circular is self-explanatory in all respects.

<sup>\*</sup> For online verification on NSP, the INO of school must be Aadhaar Authenticated. Therefore, all HoSs must ensure that their INO is Aadhaar Authenticated on NSP so that he/she may be able to do online verification of applications on NSP. In this regard, a list of schools (where INOs are not Aadhaar Authenticated on NSP, till date) is shared by the Revenue Deptt. So, early action is warranted at the end of concerned HoS/INO. The failure to comply with this direction will be viewed seriously and may attract penalties as per service rules.

It is evident from above that the HoSs/INOs have not made wide publicity among eligible minorities students for online submission of applications on NSP. Shortly, Ministry of Minority Affairs, Govt of India will convene a meeting to review status in r/o these schemes.

Therefore, Head of all type of schools are requested to ensure that eligible students under Pre-Matric and Post-Matric Scholarship Schemes for minority students may submit their online applications within aforementioned time frame. Simultaneously, INOs are advised to start online verification of applications instead of waiting the last date of

## CIRCULAR

Subject: Regarding launching of Central Sector Schemes of Pre-Matric and Post-Matric Scholarship schemes for Minority students for the year 2022-23 on National Scholarship Portal (NSP) by M/o Minority Affairs, Govt of India.

Please find enclosed herewith the letter No. F.43(23)/CSS Scholarship/2022-23/482-503 dated 01.08.2022 issued by the State Nodal Officer (Scholarship), Revenue Deptt, Govt of NCT of Delhi with the letter No. SS-15/4/2O21-Scholarship-MoMA dated 20.07.2022 (along with detailed guidelines & SOP) of the Secretary, Ministry of Minority Affairs, Govt of India on the subject cited above.

Vide the aforementioned letters, it has been informed that the Central Sector Scholarship Schemes for minorities students in school education, namely, Pre-Matric Scholarship Scheme and Post-Matric Scholarship Scheme have been

All Head of Schools are requested to go through the detailed guidelines and Standard Operating Procedures (SOP) provided with the said letters, which are also available at www.scholarships.gov.in & www.minorityaffairs.gov.in In this regard, HoSs of Govt./Govt. Aided/Recognized Unaided Pvt. Schools/MCD/MCD Aided/MCD Unaided/NDMC/DCB and KVS schools have to ensure proper dissemination of information regarding launching of schemes, its timeline, eligibility etc through displaying on school's notice board and by announcing at the time of morning assembly in school so that eligible students may apply well in time. For the purpose, school must have a Institute Nodal Officer (INO) for NSP (Minority Schemes).

As per guidelines of the schemes, the students studying in Govt./Govt. Aided/Recognized Unaided Pvt. Schools/MCD/MCD Aided/MCD Unaided/NDMC/DCB and KVS schools belonging to centrally notified minority communities viz Buddhist, Christian, Jain, Muslim, Sikh, and Zoroastrian (Parsis) may apply online on National Scholarship

- Pre-Matric Scholarship for Minority- Secured not less than 50% marks in the previous final exam and annual income of their parents/guardian from all sources does not exceed Rs. 1 Lakh.
- Post-Matric Scholarship for Minority- Secured not less than 50% marks in the previous final exam and annual income of their parents/guardian from all sources does not exceed Rs. 2 Lakh.

The briefs extracted from SOP (Point No. 4.2.2) provided by the MoMA, Govt of India are as under:

- (i) Every school must be registered on NSP and get their KYC and Aadhaar-Demo-Authentication done at the
- (ii) Nominated INO of school for NSP (Minority Schemes) must be Aadhaar Authenticated otherwise he/she will not be able to do online verification of scholarship applications in r/o aforementioned schemes and the liability for this lapse will lie on HoS/INO.

At last, it is requested to all Head of Govt./Govt. Aided/Recognized Unaided Pvt. Schools/MCD/MCD Aided/MCD Unaided/NDMC/DCB and KVS schools that they have to read guidelines and Standard Operating Procedures (attached herewith) minutely so that all eligible students can be provided proper guidance by them to apply online and their applications verified smoothly by INO within given time frame. Here, it is pointed out that during 2021-22 many school's INO had not verified applications on NSP and needy students deprived of their scholarship; this lapse has been taken very seriously by the government and it is warned that any such recurrence of lapses during current session will attract All Head of Schools
